SCHEDULE: Access Communications Group completed all design and engineering services in a timely manner. They adapted there schedule during the contract due to weather delays or to users of the facility they were working in needing it to generate

the mission. Overall the contractor would also get us a new schedule as soon as possible and it would be very manageable to succeed the work that was required from them.

COST CONTROL: Access Communications Group would submit their progress reports in a timely manner and they were very accurate based on the current status of work complete during the contract. The contractor took the correct action when funds exceeded the available funds.

MANAGEMENT: Access Communications Group was very organized by communicating throughout the project with emails or phone calls so we could address a question or problem they were running into. The project manager Eric would also visit the site frequently to check on the quality of the contract. The superintendent of the project was readily available to communicate with about any situation that would arise during the contract.

SMALL BUSINESS SUBCONTRACTING: Accu striping worked on the CV-22 apron and did a phenomenal job they were very efficient and we had no problems while they were here to do work. All requirements were met and they finished before the deadline so the CV-22 apron could operate earlier.

REGULATORY COMPLIANCE: Access Communications Group complied with all contract clause requirements, reporting requirements and the quality assurance surveillance plan through the duration of the contract. The contractor also was very keen on making sure all safety and environmental specifications were met throughout the duration of the contract.

OTHER AREAS: Finished all punch-list items the same day we did the prefinal inspection.
